## 4.4. UN Inter-Agency Network on Youth Development (IANYD) 1<sup>st</sup> open meeting, New York, 18-20 September 2013

Jenny and Jannicke attended IANYD's 1<sup>st</sup> open meeting in New York with different youth representatives from all over the world. Jenny and Jannicke on behalf of the board were involved at the education part of the meeting and the workshop during the meeting days.

# 4.5. International Coordination Meeting of Youth Organisations (ICMYO) annual meeting, New York, 21-22 September 2013

Jenny and Jannicke attended the annual meeting of ICMYO in New York. Very interesting days with other non-governmental organizations (NGO). We had workshops there we discussed guidelines for ICMYO and for ICMYO's future work about how to use voices of youth-led organizations globally. It is a great opportunity for WFDYS to be a part of this international network.

# 4.6. UN High Level Meeting on Disability and Development (HLMDD), New York, 23 September 2013

Jenny attended the HLMDD together with Colin. They attended several meetings during the day and were happy to see many government representatives on higher positions working on a inclusive post-2015 development agenda.

# 4.7. Global Partnership on Disability and Development (GPcwd) at UNICEF, New York, 24 September 2013

Jenny was a moderator on GPcwd side-event seminar on inclusive development with several speakers during the day.

#### 4.8. GPcwd Youth Council Meeting, New York, 25 September 2013

Jenny was chair at GPcwd youth meeting. The participants agreed to develop a GPcwd action list and taskforces.

#### 4.9. WFDYS lecture, Melbourne 11-12 October 2013

Ana and Jannicke were in Melbourne, and did two lectures during the days; one at a breakfast seminar for Sign Language Communications, Victoria (SLCvic) in Melbourne, were WFDYS received a donation. The second lecture was held at a deaf school in Melbourne, followed by a workshop for deaf children and juniors. We also had a workshop and an open discussion with deaf youth in Melbourne, about creating a youth club in Melbourne and a youth section or a youth association in Australia.

WFD Board has made an announcement in their board meeting that South America has a youth regional secretary. We have received a letter from Argentina that South America will have their first youth camp in 2014, but no more information is received from South America Youth yet.

<u>Decision:</u> Ana will talk with Alexeis Estbill from Chile, who represented South America at WFD Board meeting in Sydney, she will ask him about information and details around the South America's youth camp in 2014.

<u>Decision:</u> Braam is going to represent WFDYS during the general assembly, and he will observe how Oceania is following up this issue and other youth issues.

#### 7. WFDYS board evaluation

#### 7.1. Communication within the board

After the last board meeting the e-mail correspondence has continued in a good way with more international sign video added in the email. The draft of the meeting minutes from 22<sup>nd</sup> board meeting were a bit late, and this will not repeated. Jenny is interning at UN Human Right Watch during the fall period, and her internship period is making WFDYS more visible at international level, and this will give a positive effect at future WFDYS work. Jenny thanks the board for good work and are looking forward to work at the same way and for more WFDYS representations for the next half-year.

#### 9. News from the WFD Secretariat/Board

## 9.1. Approved YOM:s

Spain, Chile, Uruguay, Kenya and Philippines have been approved as YOM by the WFD board. Kosovo's application as YOM is declined; the deaf association in Kosovo is Associate Member in WFD and not Ordinary Member. It will be discussed how WFDYS and WFD will do with Kosovo's youth association.

In our last board meeting WFDYS discussed how to get a faster process with YOM applications. Ana has had a meeting with WFD MACR working group and the result from this meeting is following: If a YS (Youth Section) and their national deaf association already is an OM in WFD then WFDYS can approve those applications at our own, after each approval WFDYS would inform this to WFD, with application papers attached. Application from independent youth associations would follow the same process as earlier: WFDYS goes through the application and send this forward to WFD MACR for a final approval.

#### 10. Relationship between WFDYS and WFD

#### 10.1. WFD Human rights work group

Jenny tells that Eeva Tupi is doing great in WFD, and that the working group will try to get a deaf person to UN CRPD committee. Latest news is that UN is now working for captioning everything in UN.

## 10.2. WFD media work group

WFDYS has not proposed Braam to be leader for this group concerning our decision in our last board meeting, because this group has now decided that Dmitry Rebrov from the WFD board is the group leader. WFD has approved H3 as Associate Member, where it also has been discussed to live stream from different WFD events.

<u>Decision:</u> WFDYS is concerned that live stream can lead to fewer participants in WFD events. Braam will follow up those issues with the media work group.

#### 10.3. WFD congress workgroup

WFDYS had a meeting with WFD about WFD world congress 2015 at October 14<sup>th</sup>, in Sydney. WFDYS youth camp 2015 was also discussed in this meeting.

<u>Decision:</u> Jannicke will ask WFD congress workgroup to add Ana in the email group since she is the contact person for WFDYS youth camp 2015.

#### 10.4. WFD legal committee

Ana has talked with Terry Riley about Internal Rules and tells that changes in Internal Rules are to be done before May 2014.

<u>Decision:</u> Ana is going to update and change Internal Rules with support from Jannicke. The rest of the WFDYS board will read through this for comments before we send our updates and changes to WFD.

## 10.5. WFD CI policy

WFDYS board has not heard anything from WFD board after our board meeting in Rome. We will wait for information from them and to see the draft.

Decision: Jenny follows up this issue.

#### 10.6. Australia Conference

No much contact between Braam and the Australian's conference group. Braam asked if it is possible with a youth fee besides the participant fee for the conference; no reply is received about this issue. Braam got the youth programme before the conference and WFDYS board has sent our comments on this.

#### 10.7. **WFD congress 2015**

WFDYS board had a meeting with WFD board about WFD congress 2015 at October 14<sup>th</sup>, in Sydney, Australia.

#### 11.EUDY MoU

Jannicke has done some adjustments with the MoU between EUDY and WFDYS, WFDYS board agree with those changes. The MoU will be sent to EUDY, and we hope

that WFDYS and EUDY can sign this agreement at EUDY's general assembly in Bulgaria 2014. If not then in WFDYS' general assembly in Turkey 2015.

Decision: Jannicke will send the MoU to Ronan Dunne, the president of EUDY.

## **12.** International Coordination Meeting of Youth Organisations (ICMYO)

## 12.1. Meeting with UN envoy on Youth 21th September

WFDYS is now involved in ICMYO with 20 other non-government organizations.

# 12.2. Inter-Agency Network on Youth Development (IANYD) System-wide Action Plan on Youth focus paper on Education

WFDYS is leading the IANYD's working group "Education" and will collect information about education for the focus paper with the aim to influence on UN-level.

### 12.3. **ICMYO – internal Rules to approve**

WFDYS approved ICMYO internal rules and is looking forward to work together with other member organisations in ICMYO.

## 12.4. ICMYO position paper, UN permanent Forum on youth

WFDYS support this letter.

## 13. International Disability Alliance Youth

#### 13.1. Follow up this issue from last board meeting

WFDYS Board is happy that we are a part of ICMYO, and is now cooperation with other international non-governmental organization (NGO). In ICMYO we represent deaf youth. WFDYS has tried to cooperate with International Disability Alliance (IDA) about creating IDA Youth, so this organization can take a part of ICMYO with a perspective on disability. We agreed to postpone this try until we strengthening our network within the ICMYO.

<u>Decision:</u> WFDYS Board agrees that we represent deaf youth only, not wider youth with disabilities. We shall priority our network with other youth NGOs within the ICMYO for now until we find a need to establish another network, with other youth with disabilities NGOs.

#### 14. UNICEF Global Partnership on Children with Disability, Youth Council

#### 14.1. **GPcwd Education Taskforce**

240 different organizations are part of this, Colin Allen and Jenny attended the meeting, they were chairpersons for the meeting about education where they talked about UNICEF's global partnership. Jenny were there as a WFDYS representative,

there were only five person in this group discussion. It is a great opportunity for WFDYS to be involved, but maybe it can be too much if WFDYS board is going to lead the group.

<u>Decision:</u> WFDYS Board will ask our board member, Robert, if he wants to be involved on behalf of WFDYS Board.

Jenny opened board meeting day two with to congratulate Braam Jordaan for his birthday.

## 15. Youth Ordinary Membership

#### 15.1. Pending applications

Spain, Chile, Uruguay, Kenya and Philippines have been approved as YOM by the WFD board. Kosovo's application as YOM is declined; the deaf association in Kosovo is Associate Member in WFD and not Ordinary Member. It will be discussed how WFDYS and WFD will do with Kosovo's youth association.

#### 15.2. Meeting with WFD MARC committee

In our last board meeting WFDYS discussed how to get a faster process with YOM applications. ## 18.1. Junior Youth Camp, Italy, 2013 Evaluation

WFDYS have to fulfil our evaluation from WFDYS junior youth camp in Rome. Also we have to ask Italy to get their evaluations; one evaluation from the evaluation meeting between WFDYS and Italy's Camp Organize Committee. And also an evaluation from the Camp Organizing Committee. Evaluation from the country leader's evaluation in the last leader meeting during the camp.

<u>Decision:</u> Jannicke will write an evaluation on behalf of WFDYS, and collect the other evaluation papers from CGSI Italy, and also ask them to get the final financial overview for the camp.

#### 18.2. Children Camp, USA, 2014

First announcement is delayed because of changing of the camp location. The new location is confirmed by WFDYS, the camp will find place in Gallaudet University, Washington D.C. The camp dates are 1-8 august 2014.

WFDYS confirm the first announcement, with comments. The second announcement will be done in November. Jannicke and Eun Jung will make a video to DYUSA and DYUSA's Camp Organizing Committee about changing of the WFDYS' contact person for the camp, Eun Jung is now taking over the contact person role.

#### 18.2.1. Developing countries sponsorship

According to our decision in our last board meeting WFDYS has published video information about sponsorship of developing countries, the video was published in July. No new information is received.

<u>Decision:</u> Jenny will send an email to Robert and ask about how this issue is going.

## 18.3. Youth Camp, Turkey, 2015

WFDYS is wondering if the camp director in Turkey can get paid for the work, from the Turkey congress committee. Maybe it is necessary that Ana go to Turkey several times for supporting the work there.

<u>Decision:</u> Ana will ask EUDY about help from the Developing Country Group about to arrange a leadership training course in Turkey. Maybe the DC group can travel to Turkey with Ana.

#### **19.WFDYS Internal Rules**

## 19.1. Voting rights WFD board

Ana is going to have a meeting with Terry and send a letter to WFD about this issue.

#### 20. WFDYS Bank account

Bank information is received. New bank balance, and this includes the donation from Gallaudet University. Jenny and Eun Jung have had a meeting with WFD's financial working group, and talked about how WFD and WFDYS can cooperate for WFD's fundraising. The question is if WFDYS can get a part of WFD's fundraising, 10 % for their fundraising each year. WFD told that they are saving some of the fundraising for WFDYS, the aim is to get a full-time secretary for WFDYS board.

Eun Jung has paid for the WFDYS' USB, Eun Jung will give the receipt to Phillipa for getting the amount back.

<u>Decision:</u> WFDYS will add a new point in WFD fundraising Guidelines about fundraising for a full-time worker for WFDYS.

Because of that WFDYS now is earning money through selling items we will need our own fundraising guidelines, which will follow the WFD's guidelines. Eun Jung and Jannicke will write a sketch for the next board meeting.

#### 21. Fundraising

## 21.1. WFD fundraising guidelines 31 December

WFDYS is following the WFD's fundraising guidelines. If we have ideas for how to fundraise we can check this up with the WFD board.

## 21.2. **Mechanising proposal**

Eun Jung has fixed USB with WFDYS's logo, and we will start to sell them in the WFD conference in Australia. Eun Jung, Jannicke and Ana have new ideas for what WFDYS can sell in the future, and how to sell them.

<u>Decision:</u> WFDYS sells USB and other items only during our board meetings, presentations, at conferences and congresses and at Youth Camps.

#### 21.3. Fundraising action plan

Add a new point, every time WFDYS has a presentation, we will also mentioning that we sell WFDYS items for WFDYS fundraising.

<u>Decision:</u> WFD has said yes to help us. Jenny will have a meeting with Torun Eklund, who works in WFD about this issue. Because of a slow process with My Rights an evaluation after the end of the project will include our thoughts about how to cooperate with My Rights in the future.

WFDYS board has received a report from our interns, Drisana Levitze-Gray and Thomas McWhinney. WFDYS board is thanking them for the report, they have done a great job collecting WFDYS history. The work with collecting WFDYS history will now turn into a working group.

Two interns at the same time is maybe too much, WFDYS board will make an agreement or guidelines for the intern's role. To have interns at WFDYS camps is maybe not necessary if it is not in their task list.

<u>Decision:</u> Braam is going to make an agreement for the internship's role and this agreement shall be ready before the next intern period.

## 23.2. Next internship period, January/February – April 2014

Next internship period will be February- May. We will try to get intern from South America. A new video with information about the new internship period will be published in November / December.
