8. 2003-2007 MANDATES REVIEW

Motions:

- More time for Assembly: We created Workshop for Spain 2007.
- Brochure: Done (Sweden 2005) Reviewed Denmark 2006
- Board Guidelines: VB + TR done + ongoing
- Camp Guidelines: Done + Reviewed
- Experts Groups in WFDYS: No, **must** throughout WFD.
- More pages in WFD News: WFD News is depended on sponsors, no WFD News now.

- Regional Youth Secretary: Have sent out information regarding this, hoping that Regional Secretariats will do this.
- Voluntary Worker at WFDYS: No
- WFDYS Members (not President and Vice President) Election (voting individually or everyone at the same time): We are going to follow WFD, agreed to do individual vote in Spain 2007. TR & VB to write proposal for Internal Rules.

9. WFD CAMPS

9.1 Sweden WFD Junior Youth Camp Report

A letter was received from Swedish Deaf Youth Association (SDU) dated July 27th 2006.

9.2 Info about WFD Childrens Camp, Denmark

The DOC should have sent out a brief biography and information to WFDYS for approval before inviting them to the Camp. This is clearly stated in the Camp Guidelines. AP has been outstanding with sending out information to all WFDYS members before the Camp.

9.3 WFD Youth Camp, Spain

VB informed about the Youth Camp preparations in Spain 2007. There are many issues we need to clarify before we agree upon the Camp preparations:

- The logo is wrong spelled. Action to be made: The logo must be changed.
- No approval of theme
- No approval of Camp Site. Action: Spain SOC must solve the situation regarding playground for activities and free time.

VB will contact Spain to clarify some issues which was discussed at the meeting:

- The theme needs to be clarified
- Two persons out of the committee in the Info Sheet. Must be done.
- WFD name is wrong.

Changes to be made in the 2nd announcement:

• About Spain

Make it shorter and more interesting to read.

Place of Camp

Add a photo of the place in the announcement.

Participants

If the Camp will be full and more participants wanting to come, it is necessary to reduce the number of country participants (i.e. from 4 to 3.) That means more countries will get the opportunity to participate in the camp.

• Camp Beds

It is not acceptable to have extra beds. It should be fair to everyone. 120 participants to be maximum. But we are flexible to have 140 participants

Staff/Workers

We need to get clear information about the interpreters. They cannot participate in the camp activities, etc.

• Add: PAYMENT

It is possible to pay the whole camp payment at once, to get off the transfer tax. Also add a notice in the payment form that it is possible to contact SOC if there are any problems/questions regarding the payment.

Programme

6/7 – the 1st day of WFDYS Workshop should be International Sign.

11/7 should be the WFDYS Workshop.

Blue Ribbon Ceremony- when?

We need to get clarification about Group Dynamics. What is that?

As soon as VB gets the meeting minutes from the Spain meeting, she will send it to all WFDYS Members.

9.3.1 Spain Meeting

The communication has not been well. Spain will have regular meetings in 2007. Agreed that JD remains to be the Contact Person. VB to inform Spain about this.

10.2 Youth Assembly Workshop

It was agreed that TR & VB plan and prepare the YGA Workshop. The workshop date to be confirmed by Spain.

10.3 Youth Assembly

TR & VB will make proposals for all WFDYS Members, so we all know who will be responsible for what. There will also be two different motions –

1) OM & WFDYS Motions, 2) On Floor Motions.

10.4 SIG, our responsibilities during the Congress

VB & Spain Committee will choose presenters. All WFDYS are going to introduce the presenters at the SIG. We also discussed the opportunity for us in WFDYS to be a SIG presenter about WFDYS. We all agreed upon AP to write a proposal before October.

10.5 General YA Preparations

All of us want to stay at the same hotel as WFD.

VB has sent an email to Spain, asking for materials to the YGA, but no reply yet.

We also agreed to ask a volunteer (an old WFDYS member) to help out with registrations at the YGA. VB will look for volunteers. VB will also make a list to remember what to bring and what we would need at the YGA and then send out the list to us in WFDYS.

11.1 YOM Principles

We have time to write a proposal to WFD about YOM principles. JD & PL to do this before the Moscow Meeting. Should be sent via VB to WFD President Jokinen and KS and also the WFD Statutes Committee.

AP & JD have revised the Guidelines. An appendix will be added: Evaluation.

11.4 Revised Internal Rules

TR & VB have revised the Internal Rules. An addition should be made to the Rules:

- always have a workshop before YGA.

The Internal Rules will be sent to all WFDYS Members via e-mail.

12. ACTION PLAN 2007-2011

13. WFDYS Representations

- United Nations different areas, WFDYS is represented by VB in two areas and VB did
 not want to be represented at both.

 JAG to represent at the UN meeting in
 September.
- Japan no official invitation yet: Awaiting
- WFD Asia-Pacific RS Conference November: JD proposes to attend that conference and represent WFDYS.

General:

If we are interested in holding presentations / attend conferences on our own, it is okay to represent WFDYS. The communication should go through WFDYS President first.

14. WFDYS AND EUDY

AP informed that she got an email from EUDY's member Minna Katainen. In that email she stated that EUDY wants to participate in WFDYS Youth Camp in Spain as observers with the objective to build a network between WFDYS and EUDY.

The meeting agreed the following, that AP gets in touch with Minna Katainen and answers the questions:

- EUDY and WFDYS can invite each other to YGA's. It is not possible for EUDY to attend our Camps as observers.
- Meetings between Regional Secretariats and WFDYS and EUDY can take place before or after the YGA's. This should be open for all delegates, not EUDY only.
- We are positive about working closely in following areas: Youth Secretary, Developing Countries and Fundraising. We will propose ideas and send them to EUDY.
- We can send information to EUDY what is happening at our side and what we are doing.
- We also would clarify the matter about the Discrimination Proposal (given to the old WFDYS Board 1999-2003). We would like for EUDY to ask YOM's for more researching in this matter.

15. FUNDRAISING

We need to focus on our primary goal for the Action Plan: Fundraising.

An idea came up at the meeting: to fund money throughout selling T-shirts in Spain. The objective of doing this would be to raise money in the bank account. We must ask WFD for approval first. An idea with the T-shirt logo: To use a drawing by a participant at Childrens Camp in Denmark – must be approved by the participant and parents first.

JD also states that we need to have a clear goal with fundraising – our intentions are to support developing countries to attend camps.

16. Publicity

16.1 Brochure

The brochure is not yet done. AP/JAG to finish the brochure during the camp.

16.2 Website

We need to get done with the website as soon as possible. It has been too long now. VB and JD are going to look through all documents before sending them to CSD.

Everyone needs to check his/her own biographies for changes before they will be sent to CSD. Everyone also must send a picture of ourselves to JD. (AP + VB done with that)

JD: Add in the "Welcome Page" – Links to YOM Websites are welcome.

17. FUTURE WFDYS MEETINGS

17.1 Aal, Norway. January 2007

The dates are not confirmed yet. The meeting will be held either on the weekend of January 23rd or January 30th. Dates to be confirmed in the end of August.

Right now, Norwegian Deaf Association is checking if there will be free for WFDYS too. VB to confirm in September-October about the money situation.

17.2 Madrid, Spain. July 2007

SOC is positive that we have our meeting during the Camp time. VB to confirm to Spain that we are OK with this.

18. MISCELLANEOUS

18.1 Archives

We agreed that we need to collect all materials for the next WFDYS Members and also for future use. All materials should be at the WFD Office in Finland. Agreed that VB will do this.

18.2 Information Sheet

We discussed if the Info Sheet should be open to everyone to read. We do not think this should be kept as secret, since there is good information in the sheet for everyone to have. This will also benefit YOM to know about organisation structure and also for them to know about WFDYS functions. We need to add a Meeting Procedures Guideline, 2 different Meeting Minutes – one confidential and one official, in the Info Sheet. We also need to add in the Info Sheet that WFDYS Meeting Call should be sent out 3 months in advance. TR & VB will finish the Info Sheet before October 15.

18.3 Youth Camp Participants (Spain 2007)

We agreed that camp participants should be a maximum of 120 as stated in the 2nd announcement. Spain have the right to reduce participants if too many apply.
